Keeping our Children Safe

A parents' guide to picking up and dropping off at school





As a school, we want to know that your children are safe once they have left our care.

This leaflet details the measures we are taking to ensure your children are safe at drop off and pick up times.

Some of these are new procedures and we ask that you read this leaflet carefully.

SAFEGUARDING CHILDREN

LEAVING YOUR CHILD WITH US IN THE MORNING

In the mornings, we will register your children between 9.00am and 9.05am. **If your** child is ill, we ask that you ensure that we have received a phone call in school before 9am. To report your child's absence, please use our absence reporting hotline which allows you to leave a message at any time—no need to wait until the office is manned. If your child is not present at 9.30am and we have not heard from you will receive a call from the office. This ensures that, in the unusual case of your child being absent without your knowledge, you will know about it quickly and the appropriate authorities can be called promptly.

COLLECTING YOUR CHILD AT THE END OF THE DAY

It is essential that you complete and return the attached form.

Children are released from
their classroom doors. The
class teacher will not
release your child to
anyone (whether they are

known to the school or not) for whom we have not received your prior permission. Please list all potential end of day carers on the form. This will mean that parents MUST notify the school of any changes to usual pick up routines. e.g. if you are delayed you must call the office to inform them before the end of the day. We are confident that parents will view this as an acceptable inconvenience in light of their children's safety. Parents are asked to collect their children in order, from youngest to oldest and to be prompt. We respectfully request that parents do not come to the classroom door more than 5 minutes before dismissal as it can be very distracting for the children.

Walking Home Alone

If your child has your permission to walk home unaccompanied (or to meet you outside school) please specify on the form. Again, we will not release children until we receive your consent to do so.
