

## **INSTRUMENT OF GOVERNMENT (VARIATION)**

- 1. The name of the school is Hordle Church of England Primary School
- 2. The school is a voluntary aided school.
- The name of the governing body is "The governing body of Hordle Church of England Primary School"
- 4. The governing body shall consist of:
  - a. Three parent governors [at least two parent governors]
  - b. One local authority governor
  - c. One staff governor
  - d. The Headteacher
  - e. One co-opted governor [Such number as the governing body consider necessary. The total number of co-opted governors who are eligible to be elected as staff governors under Schedule 2, when counted with the staff governor and the headteacher, must not exceed one third of the total membership of the governing body]
  - f. Nine foundation governors [Such number as to outnumber all the other governors by two]
- 5. Total number of governors: Sixteen
- 6. The name of the body entitled to appoint six foundation governors is: The Winchester Diocesan Board of Education after consultation with the Parochial Church Council of All Saints Church, Hordle.

The name of the body entitled to appoint two foundation governors is: The Parochial Church Council of All Saints Church, Hordle after consultation with the Hordle Church of England Primary School Charity.

- 7. **(a)** the holder of the following office shall be a foundation governor ex-officio: The principal officiating minister of All Saints Church, Hordle
  - (b) the Archdeacon of the Archdeaconry within which the school is situated shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor whose governorship derives from the office named in (a) above, in the event that that ex-officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under

- regulation 21 (1) of the Regulations, or there is a vacancy in the office by virtue of which this governorship exists.
- 8. The Archdeacon of the Archdeaconry within which the school is situated is entitled to request the removal of any ex-officio foundation governor and to appoint any substitute governor.
- 9. There is a trust deed for the school dated 11 June 1859.
- 10. The ethos of Hordle Church of England Primary School is described as follows: Recognising its foundation, the school will preserve and develop its Christian character in accordance with the teaching of the Bible and in partnership with the church at parish and diocesan level.

The School aims to serve its community by providing, within the context of Christian belief and practice, an education of the highest quality possible. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experience it offers to all its pupils.

- 11. [applicable if the term of office of one or more categories of governor is shorter than four years] The term of office of N/A [category of governor] is N/A [insert period between one and four years]
- 12. This instrument of government comes into effect on 14 July 2015
- 13. This instrument was made by order of Hampshire Local Authority on 2 April 2015
- 14. A copy of the instrument must be supplied to every member of the governing body (and the head teacher if not a governor), any trustees and to the appropriate religious body.
